Occasionally we may take photographs of the children at our schools. We use these images as part of our school displays and sometimes in other printed publications. We will also use them on our schools websites, Facebook and Twitter accounts.

If we use photographs of individual pupils, we will only use the frist name of that child in the accompanying text or photo caption. If a child has won an award and the parent would like the name of the child to accompany their picture we will obtain permission from the parent before using the image.

Learning journeys, Tapestry, Seesaw and Records of Achievement are used to celebrate your child's progress throughout school. Photographs of individuals, groups or classes of children may appear on these records.

From time to time, our schools may be visited by the media who will take photographs or film footage of a high profile event. Children may appear in these images, which will sometimes be published in local or national newspapers, or on approved websites, we will ask that children are not named in any use of the images.

Brooke Hill Academy is committed to the protection of all personal and sensitive data for which we hold a responsibility as the Data Contoller and the handling of such data in line with the data protection principles, the Data Protection Act (DPA) and the General Data Protection Regualtions (GDPR).

All data within the school's control shall be identified as personal, sensitive or both to ensure that it is handled in compliance with legal requirements. Access to it does not breach the rights of the individuals to whom it relates.

We may include pictures of pupils and teachers that have been drawn by the pupils. We may use group or class photographs or footage with very general labels, such as "a
